Our records indicate your district has Directors whose seats are up for election at the **November 7, 2017 Uniform District Election**.

The Candidate Nomination period **begins July 17, 2017 and closes August 11, 2017**.

**IMPORTANT:** All current incumbents that wish to continue serving on their board **MUST** file candidate documents in person, with the County Clerk's Office, during the nomination period stated above, Monday through Friday between 8:30 am - 5:00 pm.

To insure that our records are current, review the attachment and confirm your district's contact information and list of Board Members. Confirm whether board members were elected or appointed and include any mid-term appointments that have been made to fill a vacancy for terms expiring in 2019; these board members must file candidate documents for a short term seat. Sign and date the attachment after confirming or updating the information

- Notice to the County Elections Official - Special District Fact Sheet – due June 30, 2017
- Sample Resolution Calling for an Election – due June 30, 2017
- Elected Officials and Terms of Office – due June 30, 2017
- Estimated Cost of the Candidate Statement

If a candidate authorizes another person in writing to pick up their nomination documents, the candidate must provide their name, current residence address and office/contest in which they are interested. If both full and short terms seats are available, the candidate must indicate for which term they are applying.

The following documents have legal deadlines; however it would be greatly appreciated if you would return the documents by **June 30, 2017**, to allow time for processing.
