- Legal Counsel Boranian to find out options and report back

5. Merging of Fire and PD – Legal Opinion

- Legal Counsel Boranian handed out a memorandum regarding the process
 - Consolidation may be initiated through LAFCO
 - There would need to be a joint special meeting solely regarding the merge with a subject matter expert present
- Legal Counsel Boranian requested permission to share the memorandum with the Police District which was granted
- Board member Fortune will reach out to the Police District to see if they are interested in a joint meeting

6. Service Agreement Analysis

• The board reviewed statistics regarding revenues received, expenses paid and provisions of the contract with the City of Fresno regarding what should be paid versus actual paid.

7. Policies

9. Fire Chief Updates

- Fire prevention week. We did open houses at Fig Garden and station 17. Both were well received by the public and considered a success
- Fresno Fire Dept members have been attending other Fig Garden meetings for the Women's Club, Police District and whatever is brought to our attention.
- Chief reviewed call statistics and noted that we are using a new incident system
- Introduced Chief McGuire as the new Deputy Chief of Operations. Chief McGuire spoke to his experience in the fire service
- Spoke to the Mayor making an investment in the un-homed. The Fire Dept has seen an increase in warming fires and an uptick in exterior fires.
- Fresno Fire received a grant to assess our station placements and call responses.
- A drill school started January 2 to fill retirements, resignations, or current vacancies. An invitation to visit the academy was extended to the board members.
- Chief Alcorn is meeting regularly with Chief Henry at North Central Fire Protection District to see where we can help without potentially harming our department
- There are discussions about an organizational change that would move the BC and Investigator from Station 20
