### 4. Board Member Comments/Updates

- Board Member Fortune had a list of questions which were answered
  - Q: Who rescheduled the March 21 meeting.
  - A: Inquiry was made by Chief Alcorn to the board and members Linney and Caglia decided to move the meeting.
  - Q: Why hasn't our June 30, 2023 Financial Statement been posted to the FGFPD website? A: It is not complete
  - Q: How do we improve our Insurance Services Office (ISO) rating from class 2 to class 1? A: Increase staffing. The difference between a class 2 and class 1 rating is a break in insurance premiums. However, there is not a material difference between class 2 and class 1. The material difference is between class 3 and class 2.
  - Q: When was the "About the District" on the FGFPD website last updated?
  - A: It was last thoroughly reviewed and updated January 2022 with an update to the Fire Chief information in July 2023

- Board Member Fortune mentioned the potential of removing the "Announcements" section of
  the website. Discussion was had regarding the possibilities of vamping up the website with
  content including the announcement page. Some suggestions were highlighting the open
  house at Station 20 during Christmas Tree Lane and posting firefighter events in the
  community. It was also mentioned that a dashboard could be added with interactive
  information such as a heat map

### 8. Financial Update/Fiscal Reports

- Budget Manager Dedmore presented the financial reports ending February 29, 2024.
- Sr. Management Analyst Cronin presented the Bureau of Labor Statistics (BLS) options for
  calculating the annual operating and capital dollars to be retained by the District per the
  contract with the City of Fresno. The old basis for calculations was to use the Los Angeles
  area data. BLS reorganized and the new options are All Cities or All Cities less Food Services.
  The board and City mutually agreed per the contract to use All Cities for any future
  calculations.
- Sr. Management Analyst Cronin received signature for an inter-fund transfer request of \$8,660 from the Capital Fund to the General Fund. These are left over funds sitting in "due to other funds" left over from the station remodel completed the end of calendar year 2020
- Received signatures for payment of invoices:

  - a. The Fresno Fire Department has been working on the budget for fiscal year 2025

  - d. Ther has been an up-tick in CPR saves. A new automatic devise is being tested and it is proving to be successful.
  - e. Station and Engine 20 statistics. The Fresno Fire Department is still learning the best method for pulling data from the new system.
