# Meggin Boranian – New Legal Counsel

- Meggin gave a brief overview of her experience and spoke to the board regarding goals and expectations as new legal counsel
- Board member Linney inquired about the possible merge of the Fig Garden Fire and Police Districts (a subject Board member Fortune introduced at the December 13, 2022 meeting). Board member Linney requested this item be placed on the next agenda before spending any time determining if this is an option possible under the current contract with the City of Fresno.
